Owner's Warranty Activation and Safety Awareness



The Dealer (or dealer's agent) has sold a Bobcat Weapons Inc. firearm to a customer (Owner). This Owner's Warranty Activation and Safety Awareness form must be completed <u>at the time of sale</u> for each firearm sold and a copy returned to Bobcat Weapons Inc. within ten (10) business days in order for the Warranty to be activated.

The Dealer and Owner will review the following information from the Owner's Safety and Instruction Manual and complete this form.

1. ______ The Owner acknowledges that he/she has received an Owner's Safety and Instruction Manual and a safety lock. If an Owners Safety and Instruction Manual or safety lock is missing from the contents of the box, you should contact Bobcat Weapons Inc. for a replacement free of charge, or download an Owner's Safety and Instruction Manual at http://www.bobcatweapons.com.

2. _____ The Owner acknowledges that he/she was instructed by the dealer how to safely operate the firearm in accordance with the Owner's Safety and Instruction Manual, specifically how to operate the safety.

3. _____ The Owner acknowledges that he/she was instructed by the dealer how to safely load and unload the firearm in accordance with the Owner's Safety and Instruction Manual.

4. _____ The Owner acknowledges that he/she was instructed by the dealer how to safely and properly field strip the firearm in accordance with the Owner' Safety and Instruction Manual.

5. _____ The Owner understands and will follow the four cardinal rules of firearm safety:

- 1. Treat all firearms as if they were loaded, at all times. (Many accidents occur with firearms that are handled carelessly, because they are believed to be "unloaded.")
- 2. Point the muzzle in a safe direction at all times. (A "safe direction" in which, if the firearm were to discharge, there would be no injury to anyone.)
- 3. Keep your finger off the trigger and outside the trigger guard until you are aimed at a proper target and have decided to fire. (If your finger is inside the trigger guard, you could fire your gun without intending to for instance, if you were startled, or if you slipped or lost your balance.)
- 4. Be sure of your target, and what is around and beyond it. (The bullet fired from your BW-5 rifle can travel *over one mile*, and has the potential to kill or seriously injure someone at that distance!)

6. _____ The Owner acknowledges that he/she will read and understand the Owner's Safety and Instruction Manual **<u>BEFORE</u>** handling, loading or firing the firearm.

INSTRUCTIONS: Dealer keeps the original completed Owner's Warranty Activation and Safety form with the ATF 4473 form. Dealer makes a copy for the Owner. Dealer or Owner faxes (206.350.5274) or mails (PO Box 21017, Mesa, Arizona 85277) a copy of this completed form to Bobcat Weapons Inc. within ten (10) business days of the sale. Bobcat Weapons Inc. activates the Warranty upon receipt of the completed Owner's Warranty Activation and Safety Awareness form.
